In addition to decreasing the lentils' quality in Canada, as mentioned above, talking about the lentil export market from Canada and Australia due to the uncertainty that dominates this market is a very hot subject. The main reason for this uncertainty goes back to India and its final decision on import duties. This number has decreased very little, but this decrease has not caused an increase in demand from this country because this year's lentil harvest will be higher than last year in India. On the other hand, it is said that the Indian government seeks to facilitate imports by modifying its phytosanitary rules. The overall goal of these measures is to help make lentils available in the country and lower their overall price.
